

## TERMS & CONDITIONS OF EVENT

### Conference Delegate Cancellation Policy

All cancellations must be submitted in writing via email to [bradley@ccem.com.au](mailto:bradley@ccem.com.au). Cancellations received by Friday, 14 March 2025, will be eligible for a full refund minus a \$200 cancellation fee per registration. No refunds will be issued for cancellations after 14 March 2025, although delegate substitutions will be accepted. Cancellation fees apply regardless of whether payment was made at the time of registration. Refunds will be processed to the credit card used, or to a nominated bank account if payment was made via EFT. By submitting your registration, you agree to these terms.

### Conference Tour Cancellation Policy

All cancellations must be submitted in writing via email to [bradley@ccem.com.au](mailto:bradley@ccem.com.au). Cancellations received by Friday, 14 March 2025, will be eligible for a full refund minus a \$500 cancellation fee per booking. No refunds will be issued for cancellations after 14 March 2025. Cancellation fees apply regardless of whether payment was made at the time of registration. Refunds will be processed to the credit card used, or to a nominated bank account if payment was made via EFT. By submitting your registration, you agree to these terms.

### Conference Cancellation or Postponement

If the Association determines the need to cancel the conference as an in-person event, it will either be postponed to a future date or cancelled outright. If postponed, you may transfer your registration to the new date. If the new date does not suit, you will receive a full refund minus a \$200 administration fee. If the conference is cancelled outright due to unforeseen circumstances (e.g., pandemic, terrorism, act of war, extreme weather), a refund will be provided, minus any reasonable expenses incurred by the Association up to the time of cancellation.

### Travel & Accommodation

Delegates are responsible for booking their own travel and accommodation. The Association is not responsible for any cancellation fees or penalties associated with these bookings. Travel insurance is highly recommended.
